This PGD is for the administration of inactivated influenza vaccine to individuals in accordance with the national influenza immunisation programme.

This PGD is for the administration of inactivated influenza vaccine by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).<sup>1</sup>

**The UK Health Security Agency (UKHSA) has developed this PGD to facilitate the delivery of publicly funded immunisation in England in line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>2</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition, authorising organisations must not alter [Section 3](#) 'Characteristics of staff'. Only sections 2 and 7 can be amended within the designated editable fields provided.

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.

**Individual practitioners must be authorised by name, under the current version of this PGD before working according to it.**

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Inactivated influenza vaccine is indicated for the active immunisation of individuals for the prevention of influenza infection, in accordance with the national immunisation programme and recommendations given in <a href="#">Chapter 19</a> of the Immunisation Against Infectious Disease: the Green Book, <a href="#">annual flu letter(s)</a> and subsequent correspondence and publications from UKHSA and NHSE.</p> <p><b>Note: This PGD does not cover the provision of occupational health schemes or peer-to-peer influenza immunisation (see NHS Specialist Pharmacy Service ‘<a href="#">Written instruction</a>’ template for the administration of inactivated seasonal influenza vaccine as part of an occupational health scheme, which may include peer-to-peer immunisation’). This PGD covers NHS commissioned services only (see <a href="#">Criteria for inclusion</a> below for specified frontline staff without employer-led occupational health schemes).</b></p>
<p><b>Criteria for inclusion</b></p> <p>(continued over page)</p>	<p>For the 2023 to 2024 influenza season, influenza vaccine should be offered under the NHS influenza immunisation programme to the following groups:</p> <ul style="list-style-type: none"> <li>• individuals aged 65 years or over (including those becoming age 65 years by 31 March 2024)</li> <li>• individuals aged from 6 months to less than 65 years of age in a clinical risk group category listed in <a href="#">Chapter 19</a> of the Green Book such as those with:             <ul style="list-style-type: none"> <li>○ chronic (long-term) respiratory disease, such as asthma (that requires continuous or repeated use of inhaled or systemic steroids or with previous exacerbations requiring hospital admission), chronic obstructive pulmonary disease (COPD) or chronic bronchitis</li> <li>○ chronic heart disease and vascular disease</li> <li>○ chronic kidney disease at stage 3, 4 or 5</li> <li>○ chronic liver disease</li> <li>○ chronic neurological disease, such as Parkinson’s disease or motor neurone disease</li> <li>○ learning disability</li> <li>○ diabetes and adrenal insufficiency</li> <li>○ asplenia or dysfunction of the spleen</li> <li>○ a weakened immune system due to disease (such as HIV/AIDS) or treatment (such as for cancer)</li> <li>○ morbidly obese adults (aged from 16 years) with a BMI of 40kg/m<sup>2</sup> and above</li> </ul> </li> <li>• all pregnant women (including those women who become pregnant during the influenza season)</li> <li>• household contacts of immunocompromised individuals, specifically individuals who expect to share living accommodation on most days over the winter and, therefore, for whom continuing close contact is unavoidable</li> <li>• people living in long-stay residential care homes or other long-stay care facilities where rapid spread is likely to follow introduction of infection and cause high morbidity and mortality. <p><b>Criteria for exclusion<sup>6</sup></b></p>	<p>Individuals for whom valid consent, or ‘best-interests’ decision in accordance with the <a href="#">Mental Capacity Act 2005</a>, has not been obtained (for further information on consent, see <a href="#">Chapter 2</a> of the Green Book).</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>● are less than 6 months of age</li> <li>● are aged 2 years to under 18 years for whom live attenuated influenza vaccine (LAIV) is suitable or not contraindicated (for instance due to the route or non-acceptance of porcine gelatine content). Note: LAIV should be given to those aged 2 to under 18 years of age in preference to inactivated influenza vaccine where possible, see <a href="#">LAIV PGD</a></li> <li>● have had a confirmed anaphylactic reaction to a previous dose of the vaccine</li> <li>● have had a confirmed anaphylactic reaction to any component of the vaccine or residues from the manufacturing process<sup>7</sup> (other than ovalbumin – see <a href="#">Cautions</a>)</li> <li>● have received a complete dose of the recommended influenza vaccine for the current season, unless they are individuals aged 6 months to less than 9 years in a clinical risk (or other eligible) group listed in <a href="#">Chapter 19</a> of the Green Book who should, in the first season they are vaccinated against influenza, receive a second dose of an appropriate influenza vaccine at least 4 weeks after the first dose</li> <li>● are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p> <p>(continued over page)</p>	<p>Facilities for management of anaphylaxis should be available at all vaccination premises (see <a href="#">Chapter 8</a> of the Green Book and advice issued by the <a href="#">Resuscitation Council UK</a>).</p> <p>Individuals with a bleeding disorder may develop a haematoma at the injection site (see <a href="#">Route and method of administration</a>).</p> <p>Individuals with a severe anaphylaxis to egg which has previously required intensive care can be immunised in any setting using a suitable egg-free vaccine, for instance QIVc or QIVr.</p>

<sup>3</sup> Children born between 1 September 2019 and 31 August 2021 are considered eligible.

<sup>4</sup> School children outside the usual age range for their class (for example those accelerated or held back a year) may be offered and given the vaccine alongside their peers.

<sup>5</sup> Includes children who are home-schooled or otherwise not in mainstream education.

<sup>6</sup> Exclusion under this PGD does not necessarily mean the medication is contraindicated, but it would be outside its remit and another form of authorisation will be required.

<sup>7</sup> Residues from the manufacturing process may include beta-propiolactone, cetyltrimethylammonium bromide (CTAB), formaldehyde, gentamicin, hydrocortisone, kanamycin, neomycin, octoxinol-9, octylphenol ethoxylate, polysorbate 80, sodium deoxycholate. Check the vaccine’s SPC for details.

<p><b>Cautions including any relevant action to be taken</b></p> <p>(continued)</p>	<p>Individuals with a less severe egg allergy can be immunised in any setting using a suitable egg-free vaccine, or an inactivated influenza vaccine with an ovalbumin content less than 0.12 micrograms/ml (equivalent to 0.06 micrograms per 0.5 ml dose). For details of the influenza vaccines available for the current season and their ovalbumin content, follow this <a href="#">link</a>.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>
<p><b>Action to be taken if the patient is excluded</b></p>	<p>The risk to the individual of not being immunised must be taken into account. The indications for flu vaccination are not exhaustive, and the healthcare practitioner should consider the risk of flu exacerbating any underlying disease that an individual may have, as well as the risk of serious illness from flu itself. Where appropriate, such individuals should be referred, or a PSD obtained for immunisation.</p> <p>In case of postponement due to acute illness, advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration (see <a href="#">Additional Information</a>). Where a person lacks the capacity, in accordance with the <a href="#">Mental Capacity Act 2005</a>, a decision to vaccinate may be made in the individual's best interests. For further information on consent, see <a href="#">Chapter 2</a> of the Green Book.</p> <p>Advise the individual, parent or carer about the protective effects of the vaccine, the risks of infection and potential complications if not immunised.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the individual's GP or a prescriber as appropriate.</p>
<p><b>Arrangements for referral for medical advice</b></p>	<p>As per local policy.</p>

<p><b>Off-label use</b></p>	<p>Where a vaccine is recommended off-label, as part of the consent process, consider informing the individual, parent or carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p> <p>aQIV is licensed for administration to individuals aged 65 years and over. It may be administered under this PGD to those aged 64 years and turning 65 years of age by 31 March 2024 in accordance with the recommendations for the national influenza immunisation programme for the 2023 to 2024 season (see <a href="#">annual flu letter</a>).</p> <p>QIVc is licensed for those aged from 2 years. QIVc is also recommended by <a href="#">JCVI</a> for children aged 6 months to less than 2 years and may be administered under this PGD.</p> <p>Vaccines should be stored according to the conditions detailed in the <a href="#">Storage</a> section below. However, in the event of an inadvertent or unavoidable deviation of these conditions, refer to <a href="#">Vaccine Incident Guidance</a>. Where vaccines are assessed in accordance with these guidelines as appropriate for continued use, this would constitute off-label administration under this PGD.</p> <p>Note: Different influenza vaccine products are licensed from different ages and should be administered within their licence when working to this PGD, except where permitted off-label administration has been detailed above. <p><b>Route and method of administration</b></p>	<p>Administer by intramuscular injection, preferably into the deltoid muscle of the upper arm. The anterolateral aspect of the thigh is the preferred site for infants under 1 year old.</p> <p>Individuals on stable anticoagulation therapy, including individuals on warfarin who are up-to-date with their scheduled INR testing and whose latest INR was below the upper threshold of their therapeutic range, can receive intramuscular vaccination. A fine needle (23 gauge or 25 gauge) should be used for the vaccination, followed by firm pressure applied to the site (without rubbing) for at least 2 minutes. If in any doubt, consult with the clinician responsible for prescribing or monitoring the individual's anticoagulant therapy.</p> <p>Individuals with bleeding disorders may be vaccinated intramuscularly if, in the opinion of a doctor familiar with the individual's bleeding risk, vaccines or similar small volume intramuscular injections can be administered with reasonable safety by this route. If the individual receives medication or other treatment to reduce bleeding, for example treatment for haemophilia, intramuscular vaccination can be scheduled shortly after such medication or treatment is administered. A fine needle (23 gauge or 25 gauge) should be used for the vaccination, followed by firm pressure applied to the site (without rubbing) for at least 2 minutes. The individual, parent or carer should be informed about the risk of haematoma from the injection.</p> <p>Influenza vaccines licensed for both intramuscular and subcutaneous administration may alternatively be administered by the subcutaneous route. Note: QIVc, QIVr and aQIV are not licensed for subcutaneous administration so should only be administered intramuscularly under this PGD.</p> <p>When co-administering with other vaccines, care should be taken to ensure that the appropriate route of injection is used for all the vaccinations.</p> <p>The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records. If aQIV needs to be administered at the same time as another vaccine, immunisation should be carried out on separate limbs.</p>

<b>Route and method of administration</b> (continued)	<p>Shake vaccine suspensions gently before administration (QIVr, Supemtek<sup>®</sup> solution for injection does not require shaking before administration).</p> <p>Inspect the vaccine visually prior to administration for any foreign particulate matter or discolouration to ensure appearance is consistent with the description in the vaccine's SPC.</p> <p>The SPCs provide further guidance on administration and are available from the <a href="#">electronic medicines compendium</a> website.</p>
<b>Dose and frequency of administration</b>	<p>Single 0.5ml dose to be administered for the current annual flu season (1 September 2023 to 31 March 2024).</p> <p>Children in a clinical risk group aged 6 months to less than 9 years old (including household contacts of immunocompromised individuals) who have not previously received any doses of influenza vaccine should be offered a second dose of vaccine at least 4 weeks later. The influenza vaccines are interchangeable, although the individual's age, recommended vaccine and vaccine licence should be considered (see <a href="#">Off-label use</a> section).</p>
<b>Duration of treatment</b>	<p>Single 0.5ml dose for the current annual flu season (1 September 2023 to 31 March 2024). <b>Supplies</b>	<p>Centrally procured vaccine is available via ImmForm for children.</p> <p>Supplies for administration to adults should be ordered from the influenza vaccine manufacturers/wholesalers as in previous years.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see the Green Book <a href="#">Chapter 3</a>).</p>
<b>Storage</b>	<p>Store at +2°C to +8°C. Do not freeze.</p> <p>Store in original packaging in order to protect from light.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">Vaccine Incident Guidance</a>.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority arrangements and NHSE guidance in <a href="#">(HTM 07-01): Management and disposal of healthcare waste</a>.</p>
<b>Drug interactions</b>  (continued over page)	<p>Immunological response may be diminished in those receiving immunosuppressive treatment, but it is important to still immunise this group.</p> <p>Influenza vaccines can be co-administered with other vaccines including COVID-19 and shingles vaccines (see <a href="#">Route and method of administration</a>). Initially, a seven day interval was recommended between Shingrix<sup>®</sup> (shingles) vaccine and adjuvanted influenza vaccine (aQIV) because the potential reactogenicity from two adjuvanted vaccines may reduce the tolerability in those being vaccinated. Interim data from a US study on co-administration of Shingrix<sup>®</sup> with adjuvanted seasonal influenza vaccine is reassuring. Therefore, an appointment for administration of</p>

<b>Drug interactions</b> (continued)	<p>the seasonal influenza vaccine can be an opportunity to also provide shingles vaccine (see <a href="#">Shingrix® PGD</a>).</p> <p>Where aQIV is given with other vaccines, including other adjuvanted vaccines, the adverse effects of both vaccines may be additive and should be considered when informing the recipient. Individuals should also be informed about the likely timing of potential adverse events relating to each vaccine. If the vaccines are not given together, they can be administered at any interval.</p> <p>A detailed list of drug interactions is available in the SPC for each vaccine, which are available from the <a href="#">electronic medicines compendium</a> website.</p>
<b>Identification and management of adverse reactions</b>	<p>Pain, swelling or redness at the injection site, low-grade fever, malaise, shivering, fatigue, headache, myalgia and arthralgia are among the commonly reported symptoms after intramuscular vaccination. A small painless nodule (induration) may also form at the injection site. These symptoms usually disappear within 1 to 2 days without treatment.</p> <p>Immediate reactions such as urticaria, angio-oedema, bronchospasm and anaphylaxis can occur.</p> <p>A higher incidence of mild post-immunisation reactions has been reported with adjuvanted compared to non-adjuvanted influenza vaccines.</p> <p>The frequency of injection-site pain and systemic reactions may be higher in individuals vaccinated concomitantly with inactivated influenza vaccine and pneumococcal polysaccharide vaccine (PPV23) compared to vaccination with influenza vaccine alone and similar to that observed with PPV23 vaccination alone. Influenza vaccine and PPV23 may be administered at the same visit or at any interval from each other.</p> <p>A detailed list of adverse reactions is available in the SPC for each vaccine, which are available from the <a href="#">electronic medicines compendium</a> website.</p>
<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals, parents and carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the <a href="#">Yellow Card reporting scheme</a> or by searching for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>QIVc, QIVr and aQIV are black triangle vaccines. All suspected adverse reactions to these vaccines should be reported via the <a href="#">Yellow Card reporting scheme</a>, as these particular vaccines are newer to market.</p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed as appropriate.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer the marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>For information leaflets in accessible formats and alternative languages, please visit <a href="#">Home-Health Publications</a>.</p> <p>Where applicable, inform the individual, parent or carer that large print, Braille or audio CD PILs may be available from emc accessibility (freephone 0800 198 5000) by providing the medicine name and product code number, as listed on the <a href="#">electronic Medicines Compendium</a>.</p>
<b>Patient advice and follow-up treatment</b>	<p>Individuals should be advised regarding adverse reactions to vaccination and reassured that the inactivated vaccine cannot cause influenza. However, the vaccine will not provide protection for about 14 days and does not protect against other respiratory viruses that often circulate during the flu season.</p>

<p>(continued over page)</p> <p><b>Patient advice and follow-up treatment</b></p> <p>(continued)</p>	<p>Immunosuppressed individuals should be advised that they may not make a full immune response to the vaccine. Therefore, consideration should be given to the influenza vaccination of their household contacts.</p> <p>Inform the individual, parent or carer of possible side effects and their management.</p> <p>The individual, parent or carer should be advised when to seek medical advice in the event of an adverse reaction and encouraged to report this via the <a href="#">Yellow Card reporting scheme</a>.</p> <p>When applicable, advise the individual, parent or carer when to return for vaccination or when a subsequent vaccine dose is due.</p>
<p><b>Special considerations and additional information</b></p>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1,000 injection and easy access to a telephone at the time of vaccination.</p> <p>Minor illnesses without fever or systemic upset are not valid reasons to postpone immunisation. If an individual is acutely unwell, immunisation may be postponed until they have fully recovered.</p> <p>For children under the age of 16 years, those assessed as Gillick competent can self-consent (for further information on consent, see <a href="#">Chapter 2</a> of the Green Book).</p> <p>Individuals with learning disabilities may require reasonable adjustments to support vaccination (see <a href="#">Flu vaccinations: supporting people with learning disabilities</a>). <p><b>Records</b></p>	<p>Record:</p> <ul style="list-style-type: none"> <li>• that valid informed consent was given</li> <li>• name of individual, address, date of birth and GP with whom the individual is registered</li> <li>• name of immuniser</li> <li>• name and brand of vaccine</li> <li>• date of administration</li> <li>• dose, form and route of administration of vaccine</li> <li>• quantity administered</li> <li>• batch number and expiry date</li> <li>• anatomical site of vaccination</li> <li>• advice given, including advice given if excluded or immunisation declined</li> <li>• details of any adverse drug reactions and actions taken</li> <li>• supplied via PGD</li> </ul> <p>Records should be signed and dated (or password controlled on e-records).</p> <p>All records should be clear, legible and contemporaneous.</p> <p>As a wide variety of influenza vaccines are available on the UK market each year, it is especially important that the exact brand of vaccine, batch number and site at which each vaccine is given is accurately recorded in the individual's records.</p> <p>It is important that vaccinations given either at a general practice or elsewhere (for example at antenatal clinics) are recorded on appropriate health records for the individual (using the appropriate clinical code) in a timely manner. If given elsewhere, systems should be in place to ensure a record of vaccination is returned to the individual's general practice to allow clinical follow-up and to avoid duplicate vaccination.</p>
